### RESOLUTION 2018-22

#### *INTRODUCTION OF THE ESTABLISHMENT OF THE PAID POSITION OF SENIOR ACCOUNT CLERK FOR THE MOUNT LAUREL FIRE DISTRICT #1*

**WHEREAS**, N.J.S.A. 40A:14-81.1 provides that a Fire District may establish paid positions within the Fire District by resolution, as shall be determined by the Board of Fire Commissioners for the purposes of the Fire District; and,

**WHEREAS**, the Board of Fire Commissioners has determined that the establishment and creation of the paid position of SENIOR ACCOUNT CLERK is required for the purposes of the Fire District; and,

**NOW, THEREFORE**, be it resolved by the Board of Fire Commissioners of Fire District #1, Township of Mount Laurel, Burlington County, New Jersey as follows:

- (1) The position of SENIOR ACCOUNT CLERK is hereby established.
- (2) The compensation, benefits and terms and conditions of employment for this position shall be as determined by the Commissioners and as otherwise mandated by New Jersey statutory law.
- (3) The SENIOR ACCOUNT CLERK shall undertake any and all responsibilities and administrative obligations relative to the fire district as required and as directed by the Commissioners.
- (4) The SENIOR ACCOUNT CLERK shall be under the supervision of the Commissioners as designated by the Commissioners pursuant to N.J.S.A. 40A:14-81.3.
- (5) This resolution shall take effect following final adoption and publication pursuant to New Jersey statutory law.

**NOTICE**, is hereby given that the above resolution was introduced and passed upon Introduction (first reading) at a regular meeting of the Commissioners held on March 19, 2018 and will be considered for final passage (second reading) at a regular meeting to be held May 21, 2018 at 7 p.m. at the Headquarters Station, 69 Elbo Lane, Mount Laurel, New Jersey at which time and place any person wishing to be heard shall be given the opportunity.

PLEASE TAKE FURTHER NOTICE that copies of said resolution shall be made available to each person requesting a copy of same during the week prior to the second reading of this resolution and during the hearing concerning the same, and said copies may be obtained from the Commissioners.
